**ORDER**

The Court having received a report from the Merit Selection Panel established by this court on January 4, 2010, and being in concurrence with the Panel's recommendation that Ross A. Walters should be reappointed as a full-time Magistrate Judge for the Southern District of Iowa,

IT IS ORDERED, pursuant to the authority conferred by 28 U.S.C. § 631, et seq., and the further authority granted and action taken by the Judicial Conference of the United States, that Ross A. Walters be, and hereby is, reappointed as Full-Time United States Magistrate Judge for the Southern District of Iowa, with his official duty station at Des Moines, Iowa.

Magistrate Judge Walters shall enter upon the performance of his duties on November 14, 2010. Prior to the commencement of his service, he shall take the oath or affirmation prescribed by 28 U.S.C. §§ 453 and 631(g).

Magistrate Judge Walters shall hold and discharge the duties of his office for a term of eight years.

Magistrate Judge Walters shall have the powers, authority, and jurisdiction to perform all duties within the Southern District of Iowa that are conferred and imposed by law upon United States

Magistrate Judges, and he shall also perform magistrate judge duties in other districts where magistrate judges of this court are authorized to serve.


Magistrate Judge Walters is hereby specifically designated to try persons accused of, and sentence persons convicted of, misdemeanors committed within the Southern District of Iowa.

The Clerk of Court shall cause copies of this appointment to be spread upon the records of all divisions of this court and shall likewise forward a copy of this appointment to the Director of the Administrative Office of the United States Courts, as required by 28 U.S.C. § 631(h).


